A nation free from hegemony and nepotism.

A nation where every man could buy and sell, to worship as he may, to own property on which to build and grow without constraints imposed by European monarchs.

A nation where each would live in harmony with every other.

A new land. A new world.

A new way for rulers to rule ... under the people!

At its heart, however, is a secret no generation can long ignore.

Law is sacred.

The Rule of Law alone paves the way to peace.

War and every strife spring from not knowing or ignoring law.

War begins in the struggles of those who attempt to live outside the law, the hypocrisy of those who presume to know what the law should be in

every last detail, and those who take unfair advantage of the millions who haven't the slightest notion how it's all supposed to fit together.

War is not so much the result of not being able to stop war as it is the result of not knowing how to avoid it in the first place.

Rudolph von Jhering, a 19th Century jurist, wrote wisely, "The end of the law is peace. The means to that end is war."

Let us choose leaders who believe in us and want what's best for our children and for generations yet to come.

Let us give our people legal knowledge so they can speak to power with effectiveness and guide their government aright, according to their will.

Let us give them liberty to share ideas, to decide for themselves if they wish to suffer despotism or celebrate liberty under law.

Let us show them the horrors of the threatened rule of globalism, and the unendurable nightmare that is anarchy.

Let us encourage them to exert the small effort required to be true civil citizens in this hour while there's yet time for us to hold the line.

Never has the world more needed a nation of civility and wisdom to look to as military technology advances in the hands of oligarchs determined to be law unto themselves.

How dare we praise our export of democracy, when our people know little or nothing about the system of laws that make democracy possible?
